COVID-19 2020

For all our academic institutions, this year has seen unprecedented challenges and precipitated many unwelcome changes. We have all been required to adapt and adopt new practices.

For the Society of New Testament Studies, this year has been no different. It was with great regret that the inevitable decision had to be made to cancel our warmly anticipated Rome 2020 General Meeting.

Accordingly, an online Business Meeting was instead held on 31 July 2020 (www.youtube.com/watch?v=Aih4EMM6khw). A detailed report of the meeting was subsequently emailed to members by the President.

At this Business Meeting, the following announcements were made:

Prof. John Kloppenborg (Canada) would continue as *President* of the Society for one further year.

Prof. Margaret Mitchell (USA) would continue serving as President-Elect, and become President instead at the 2021 General Meeting.

Prof. John Barclay (UK) would, in turn, become President of the Society at the 2022 General Meeting.

Prof. Todd Still was elected to serve as Secretary from 2021 and Prof Christina Kreinecker as Assistant Secretary - both for five years.

Profs Daniel Gerber (France) and Korinna Zamfir (Romania) retired from the Committee. Profs Régis Burnet (Belgium) and François Tolmie (South Africa) have been appointed to serve on the Committee for a period of three years.

Leuven 2021

The Society will meet next year at the KU Leuven University, Belgium, from 27-31 July.

The Local Organising Committee, led by Prof. Joseph Verheyden, very much hopes to be able to welcome members and guests to the University. The organisers are currently making preparations for three types of meeting: inperson, hybrid, and online-only. A decision about the format will be made in the the early months of 2021 in consultation with the SNTS Committee. In case of a hybrid or online-only conference, the schedule will be adapted (only afternoon slots, starting on Tuesday and ending on Saturday afternoon), so as to allow as many members as possible to attend. A regularly updated website is available at www.snts2021.com.

Main Papers: the Presidential Address will be delivered by Prof. Margaret Mitchell (USA), and six Main Papers are expected, including from Profs Bernadette Brooten (USA), Christos Karakolis (Greece) and Lutz Doering (Germany).

Seminars: there will be 18 seminars. Conveners of seminars are reminded that this programme has to be submitted to the <u>Secretary</u> by the beginning of February, 2021, so that it can be published in the February-March Newsletter. Members who would like to present a paper in one of the seminars should contact the appropriate conveners (see below: Current Seminars).

Offered Short Papers: it is expected that there will be 18 slots for Short Papers. Members wishing to offer a Short Paper of 25 minutes should send a proposal to the <u>Secretary</u>. Short Papers may be offered in English, German or French. Proposals received before 1st February will receive preference. The proposal should be

accompanied by a short abstract or outline. New members are especially encouraged to take advantage of this opportunity to present their research.

Please note that members may deliver only one paper (of any kind) at a General Meeting.

Nomination of Guests: members may invite up to two guests and are strongly encouraged to keep the Society's commitment to diversity in mind when doing so. Those wishing to nominate a scholar to be a guest at this General Meeting should submit the name, in the new year, to the Assistant Secretary. The invitation will come formally from the President. An individual may be invited up to three times in any five year **period.** However, candidates for membership of the Society may not attend a General Meeting while they are being nominated for membership of the Society. (In order to avoid embarrassment, members should ensure that their annual subscription is paid before proposing a guest invitation.) Guests are of two kinds:

- 1. Personal guests (as distinct from 'accompanying persons' such as partners or children). Any member attending a General Meeting may nominate up to two nonmembers to be invited to attend as a personal guest. These guests may participate fully in the academic programme, although not as a presenter. Members should indicate briefly to the Assistant Secretary how their quest would contribute to the proceedings. It is recommended that requests be submitted by 1st April, although later requests may be considered if there is additional capacity. These guests will be asked to pay an additional registration charge of ca. €15 in lieu of Membership subscriptions.
- 2. Seminar guests. Seminars may make application through the <u>Assistant Secretary</u> to extend an invitation to a seminar guest whose expertise is germane to the work of the seminar. Such guests can be invited for one, two, or three consecutive years, and not necessarily to present a paper each year. Only one guest may present a paper, but there is no restriction on guest respondents or guest participants. Thus a seminar might have multiple guests at a seminar, but only one guest presenter. Seminar conveners should

provide a clear and strong rationale for the invitation, including the expertise that the seminar guest has to offer, and the intended outcomes of the seminar. Requests to invite a seminar guest must be received by the <u>Assistant Secretary</u> by 1st February.

Financial Support for Members and Guests attending the General Meeting: members from the regions of the Society's international initiatives (Eastern Europe, Africa, Asia/Pacific and Latin America/Caribbean) may be eligible for sponsorship (financial support) from the International Fund to attend the General Meeting. Applications for sponsorship to attend are based on need and are to be submitted to the chair of the appropriate Liaison Committee with an accompanying rationale which makes the case for sponsorship. The chair then submits the applications to the Assistant Secretary for International Initiatives, Prof. Bill Loader, for approval.

Guests from these regions may also be eligible for sponsorship. Members (or the Liaison Committees) may request guest invitations, following the procedure detailed above. If an invitation is offered, the guest may then apply for sponsorship.

The Society normally sponsors up to twelve scholars per year. Applications for funding should be submitted by 1st February if possible. Requests received by this date should allow applicants to book cheaper flights and deal with possible visa issues in a timely manner.

Additionally, in recent years the Society has made it possible for members and guests from regions covered by its International Initiatives Programme to present research posters highlighting their own research and research in their particular region. This opportunity has been open to all who are not otherwise presenting or responding to papers and is offered both as a way of their possibly eliciting external travel funding and as an opportunity to help Society members appreciate the research being undertaken in their regions. The regions covered by the Liaison Committees of the International Initiatives Program are: Africa, Latin America and the Caribbean, Asia-Pacific, and Eastern Europe. Further details are available from Prof. Bill Loader, and applications should be submitted by 1st April.

Nomination of New Members
